### 3. System Upgrade – Deep Dive

- Funding balance of expected upgrade cost + initial bump in operating funding for test site included in Governors 2021 budget proposal.
- Schedule Project initially was to start July of 2023. If we can, we would like to start earlier than that for the simulcast systems in Rapid City and Sioux Falls. Motorola would like to start July 2022 on those two, but less likely to happen than more. SF/Minnehaha has stated that they will not be ready that early.
- Working on contract right now, hope to have that wrapped up shortly.
- Big part of the contract will be acceptable milestones for payment.

## 4. Outage 11-02-2019 to 11-03-2019

- Improper breaker disengaged when doing routine maintenance on the UPS system.
- Master Site is redundant internally, but no secondary site to back up.

- Hard outage resulted in damage to several pieces of equipment, some of which we no longer had spare parts for. Currently we are running all sites but some are cabled direct rather than running though network equipment which allows visibility.
- Working through the secondary market for parts, hope to have all monitoring/control capabilities returned shortly.
- Sites-operating normally. Monitoring-have notice into FAA on tower light monitoring.



- Requesting around \$230k for updated system support & \$5.1M for balance of system cost, FY22.




#### 2. Grant Status, all grants --





### South Dakota Public Safety Communications Council Broadband Sub-Committee

The South Dakota Public Safety Communications Council(SDPSCC) recognizes the value of all forms of communication utilized by first responders. As the representative interoperability body responsible for setting standards for our communicators, the SDPSCC has been promoting and working on interoperability for the radio side since 2007 and would like to get ahead of the new technologies coming to our world.

With the advent of FirstNet and other first responder mobile/LTE broadband services along with a host of applications without any interoperability path, the SDPSCC would like to establish a working group to lay the framework for recommended first responder applications and tools for broadband. We expect this group to review the current state of the industry, review experiences with applications currently in use, and develop a list of applications that we would consider to be <u>recommended</u> (not required) standard.

We would appreciate participation from our first responders, agency IT personnel, along with industry and carrier representatives to provide a balance of user experience, security and infrastructure, and what is coming. The SDPSCC has completed a statewide survey on this topic, and the group will have those results to begin with, so a good start has been made. We will not limit meeting size to encourage as much participation as possible.

## 6. Key-File, code-plug template

A "System Key" file is required to be programmed into any radio needing access to our network. A new Key has been received for the P25 system from both Motorola, and EFJ/Kenwood and work has been underway to develop a template for new & reprogrammed radios to allow programming when radios are in shop. The first P25 codeplug was delivered to Sioux Falls 2-Way for the Watertown PD in November.

#### 6-cont

Utilizing existing equipment on hand the cost of the test site has dropped to \$83K. Work is underway to get that procurement completed. A most likely location for the site will be in Pierre.

#### 7. Encryption Standard

- AES-256 is the only standard allowed for funding by DHS
- OEM funding limited number of encrypted devices
- Agencies are not <u>required</u> to run encryption, but if they want to participate with those that do, we recommend that they equip their radios with AES-256.
